# **Embassy News**

In the first half of 2025, the British Embassy in Washington (BEW) was laser focused on building relationships with the new Trump Administration and securing a trade deal that benefits businesses on both sides of the Atlantic. This was achieved through targeted dialogue between Embassy officials, HMG representatives from London, UK and US business stakeholders, and US policy makers. Through the deployment of high-level diplomatic tools like, the state visit of Prime Minister Starmer in late February and continuous talks between Embassy Trade representatives and the office of the US Trade Representative, the Embassy secured the first - and so far only -Trade Deal with the Trump Administration. This landmark achievement, codified through a signing ceremony at the G7 earlier in June, saved thousands of jobs and protected key British sectors.

In addition to securing a Trade Deal, the British Embassy continues to build relationships with Members of the 119<sup>th</sup> Congress and advance UK business priorities. Earlier this year, the British Embassy took a bipartisan delegation of tax and trade congressional staffers to the UK.



# British Embassy Washington

The delegation met with UK government officials to discuss transatlantic tax policy and explore how the US and UK can continue to deepen their economic relationship through trade. The US congressional delegation also toured auto and defense manufacturing plants to see the importance of the UK manufacturing landscape. As the policy and regulatory landscape for British goods and services continues to evolve in the US under the Trump Administration, the Embassy remains agile and in touch with key decision makers in order to best advocate for British businesses.

## An American Shield: Lockheed Martin and Missile Defense Agency Demonstrate Critical Radar Capability, Strengthening Homeland Defense



Lockheed Martin (NYSE: LMT) and the Missile Defense Agency (MDA) have successfully executed Flight Test Other-26a (FTX-26a). During FTX-26a, the Lockheed Martin-built Long Range Discrimination Radar (LRDR) successfully detected, tracked, and discriminated a live ballistic missile threat in a complex environment, demonstrating its ability to provide critical data to homeland defense systems.

"Deterrence begins with detection, and the successful FTX-26a demonstration underscored LRDR's ability to detect and track threats at extended ranges, while accurately distinguishing between targets and non-targets," said Rick Cordaro, vice president of Lockheed Martin's Radar and Sensor Systems. "This technical advancement will significantly bolster our nation's deterrence capabilities, providing a game-changing asset for homeland defense. With its open architecture, LRDR will facilitate the seamless integration of emerging technologies and software, enabling warfighters to receive timely, actionable information for decision-making and drives rapid response."

FTX-26a took place over the north Pacific and demonstrated LRDR's capabilities against an air-launched threat - representative target with countermeasures. Under the command of Command and Control Battle Management and Communications (C2BMC), LRDR successfully tracked the target and forwarded data to C2BMC which was successfully shared the flight test data to support a simulated Ground-Based Midcourse Defense (GMD) engagement.

The mission achieved the following firsts:

• LRDR demonstrated the detection, tracking, and discrimination of threats in a complex environment.

• C2BMC provided LRDR flight test data to support a simulated GMD engagement.
