

### **Embassy News**

Summer 2024 saw a busy programme of diplomatic, military, economic, political, and social engagements to enhance the UK/US alliance.

On June 7th, British Ambassador to the US Dame Karen Pierce hosted a celebration of the UK/US military alliance using public diplomacy through sport with the 3rd annual UK-US Friendship Day at Nationals Park.

After the UK election in early July, the Embassy quickly moved to reaffirming the strength of the Special Relationship. The British Embassy supported a wide range of engagements during the 75th NATO Summit in DC to formally introduce the UK's new Prime Minister, Foreign Secretary, and Defence Secretary to the world stage. Alongside heads of state from 32 NATO Allies, the UK signed the Washington Summit Declaration in support of Ukraine.

Ambassador hosted a reception for key stakeholders at the British Embassy Residence. UK delegates travelled to Miami, Seattle, and Austin for further engagement. To ensure that UK/US economic ties stretch across the nation, the San Francisco's Consulate General and her team attended meeting with high level government officials from Montana and Wyoming including Wyoming Governor Gordon and Montana Lieutenant Governor Kristen Juras. In August, the Chancellor of the Exchequer, the Right Honorable Rachel



## British Embassy Washington

Honorable Rachel Reeves MP, visited New York City to engage with large-scale investors from Blackrock, Citibank, Vanguard, BNY, Barclays, Cyrus One, and State Street to promote the new Labour government's economic growth agenda and the UK as a premier destination for US investment.

In tech news, the UK's Department of Business and Trade in San Francisco attended the RSA Conference to promote the UK's innovation and leadership in cybersecurity. The British Consulate General in Houston team hosted a delegation of UK tech companies in Austin, TX to explore the tech ecosystem in Texas and why UK companies should do business in the region. In July, the British Consulate General in San Francisco hosted a roundtable with the Generative AI Collective, gathering the Bay Area's tech experts to discuss robotics, the likelihood of a robotics "ChatGPT moment," the most likely commercialised use cases, and how global communities can best support innovators in commercialising technologies.

To deepen the UK/US economic and trade relationship a UK delegation travelled to DC for the SelectUSA Investment Summit and the British

In June, the British Embassy celebrated the King's Birthday with a reception at the residence. The Embassy used this engagement to strengthen relationships with contacts and promote iconic British brands. The British Ambassador, the Senior Vice President of BP, and the CEO of Barclays gave remarks.

The whole of the UK's US Network celebrated LGBT+ Pride Month, with the British Embassy marching with its own float in the Capital Pride Parade, the British Consulate General in Boston marching in the "Boston Pride for the People Parade," and the British Consulate General in LA marching in the Los Angeles Pride Parade.

The Embassy looks forward to using our collaboration with BABA to continue fostering UK/US economic partnership and growth in the coming months.

# Rolls-Royce begins R130 engine testing in Indianapolis, successfully completes testing at NASA Stennis Space Center

On August 6, 2024, Rolls-Royce (LSE: RR., ADR: RYCEY) announced testing on the F130 engine has begun in Indianapolis, another step towards delivering for the United States Air Force B-52J Stratofortress. Sea-level testing of the First Engine to Test (FETT) will run the initial software release for the F130 in the newly refurbished Test Cell 114.

In addition, Rolls-Royce is wrapping up successful Rapid Twin Pod Tests this week. Testing at NASA Stennis marked the first time F130 engines were tested in the dual-pod



engine configuration of the B-52 aircraft. The tests produced critical performance data, validating Rolls-Royce's analytical predictions — including performance in crosswind conditions, and further de-risking the integration of the F130 engine onto the B-52J.

Testing at NASA Stennis has played a key role in meeting initial testing goals and delivering at exactly the pace defined by the Air Force. This test data informs the production configuration of the F130 engine Critical Design Review (CDR), on schedule for the fall of 2024.
